I-5 SB on-ramp from OR273 SB (Ashland)

Effective **July 22, 2021**, the I-5 southbound on-ramp from OR273 southbound will be intermittently closed Sunday through Thursday nights between the hours of 7 PM & 7 AM. The estimated completion date for this project is **August 12, 2021**.

I-5 SB on-ramp from OR273 at Exit 6 (Ashland)

Effective **April 21, 2021**, the I-5 southbound on-ramp from OR273 at Exit 6 will be intermittently closed at all hours. The estimated completion date for this project is **October 1, 2021**.
