ROAD RESTRICTIONS

Interstate Routes

I-5 NB & SB MP 117.70 to MP 125.40 (Roseburg)

Effective January 13, 2019, this section of I-5 northbound and southbound will be restricted to 16 feet 00 inches in width Sunday through Thursday nights between the hours of 8 PM & 5 AM.

I-5 NB & SB MP 117.70 to MP 125.40 (Roseburg)

Effective January 13, 2019, this section of I-5 northbound will be restricted to 16 feet 00 inches in height and 16 feet 05 inches in height southbound Sunday through Thursday nights between the hours of 8 PM & 5 AM.

I-5 NB Exit 260 (Salem)

Effective January 31, 2019, this section of I-5 northbound under Chemawa Rd at MP 260.20 will be restricted to 17 feet 03 inches in height between the hours of 11 PM & 4 AM.

I-5 SB MP 288.00 to MP 290.00 (Tualatin)

Effective February 21, 2018 this section of I-5 southbound will be restricted to 16 feet 00 inches in height Sunday through Thursday nights 8 PM to 5:30 AM; Friday nights 8 PM to 8 AM; and Saturday nights 8 PM to 9 AM.

I-5 SB Exit 288 to I-205 NB (Portland)

Effective July 22, 2018, the I-5 southbound ramp to I-205 northbound will be intermittently closed Sunday through Thursday nights between the hours of 10 PM & 5 AM; Friday nights between the hours of 11 PM & 7 AM; and Saturday nights between the hours of 11 PM & 8 AM.

I-5 NB & SB Exit 289 on- and off-ramps to/from Nyberg St (Tualatin)

Effective July 12, 2018, the I-5 NB & SB Exit 289 on- and off-ramps to/from Nyberg St will be intermittently closed per the following schedule: Sunday to Thursday nights from 10 PM to 5 AM; Friday nights from 11 PM to 7 AM; Saturday nights from 11 PM to 8 AM.

I-5 NB & SB Exit 290 on- and off-ramps to/from Lower Boones Ferry Rd (Tualatin)

Effective July 12, 2018, the I-5 NB & SB Exit 290 on- and off-ramps to/from Lower Boones Ferry Rd will be intermittently closed per the following schedule: Sunday to Thursday nights from 10 PM to 5 AM; Friday nights from 11 PM to 7 AM; Saturday nights from 11 PM to 8 AM.

I-5 NB & SB Exit 291 on- and off-ramps to/from Carman Dr (Tigard)

I-5 NB Exit 292A to OR217 (Tigard)

I-5 NB Exit 292B to Kruse Way (Tigard)

Effective July 12, 2018, the I-5 NB Exit 292B ramp to Kruse Way will be intermittently closed per the following schedule: Sunday to Thursday nights from 10 PM to 5 AM; Friday nights from 11 PM to 7 AM; Saturday nights from 11 PM to 8 AM.

I-5 NB on-ramp from SB OR217 / Kruse Way (Tigard)

Effective July 12, 2018, the ramp from SB OR217 / Kruse Way to I-5 NB will be intermittently closed per the following schedule: Sunday to Thursday nights from 10 PM to 5 AM; Friday nights from 11 PM to 7 AM; Saturday nights from 11 PM to 8 AM.

I-5 SB Exit 292 on- and off-ramps to/from OR217/Kruse Way (Tigard)

Effective July 22, 2018, the I-5 SB Exit 292 on- and off-ramps to/from OR217/Kruse Way will be intermittently closed per the following schedule: Sunday through Thursday nights from 10 PM to 5 AM; Friday nights from 11 PM to 7 AM; Saturday nights from 11 PM to 8 AM.

I-5 SB Exit 293 on- and off-ramps to/from Haines St (Tigard)

Effective **October 23, 2018**, the I-5 **SB** Exit 293 on- and off-ramps to/from Haines St will be intermittently closed on Sunday to Thursday nights between the hours of 8 PM and 5 AM.

I-5 SB Exit 294 on- and off-ramps to/from OR99W/Barbur Blvd (Tigard)

Effective **October 23, 2018**, the I-5 **SB** Exit 294 on- and off-ramps to/from OR99W/Barbur Blvd will be intermittently closed per the following schedule: Sunday through Thursday nights from 10 PM to 5 AM; Friday nights from 11 PM to 7 AM; Saturday nights from 11 PM to 8 AM.

I-5 NB Exit 300 to I-84 EB (Portland) -- NEW --

Effective February 1, 2019, the I-5 northbound off-ramp to I-84 eastbound will be restricted to 12 feet 00 inches in width Sunday through Thursday nights between the hours of 10 PM & 5 AM; Friday and Saturday nights between the hours of 10 PM & 7 AM. Loads wider than 12 feet 00 inches in width can be accommodated on a case-by-case basis. Contact the Over-Dimension Permit Unit for information.

I-5 NB Exit 300 to I-84 EB (Portland) -- NEW --

Effective February 1, 2019, the I-5 northbound off-ramp to I-84 eastbound will be restricted to 15 feet 00 inches in height Sunday through Thursday nights between the hours of 10 PM & 5 AM; Friday and Saturday nights between the hours of 10 PM & 7 AM.

I-5 SB MP 301.911 to MP 301.70 (Portland)

Effective January 25, 2019, this section of I-5 southbound will be restricted to 13 feet 00 inches in width between the hours of 10 PM & 5 AM.

I-5 SB Exit 300B to US26 East/OMSI/Oregon City (Portland)

Effective January 25, 2019, the SB Exit 300B off-ramp will be closed between the hours of 10 PM & 5 AM.

I-5 SB to I-84 EB (Exit 301 - Portland)

Effective September 20, 2018, the I-5 southbound off-ramp to I-84 eastbound will be closed Monday through Thursday nights between the hours of 10 PM & 5 AM. In addition, starting Friday nights at 10 PM, this ramp will be closed at all hours, until 5 AM Monday mornings.

I-5 NB & SB Exit 303 (Swan Island/N Going St - Portland)

Effective July 23, 2018, the I-5 **northbound and southbound** on/off ramps (Exit 303) will be intermittently closed **Sunday through Saturday nights between the hours of 9 PM & 5 AM.**

I-5 SB on-ramp from Alberta St (Portland)

Effective July 27, 2018, the I-5 southbound on-ramp from Alberta St will be intermittently closed **Sunday through Saturday nights between the hours of 9 PM & 5 AM.**

I-5 NB on-ramp from Alberta St (Portland)

I-5 NB & SB Exit 304 (Rosa Parks - Portland)

Effective August 13, 2018, the I-5 northbound and southbound on and off ramps to Rosa Parks Way will be intermittently closed **Sunday through Saturday nights between the hours of 9 PM & 5 AM.**

I-5 NB & SB on/off ramps to US30 Bypass (Portland)

Effective July 17, 2018, the I-5 northbound and southbound on/off ramps to/from US30 Bypass will be intermittently closed **Sunday through Saturday nights between the hours of 9 PM & 5 AM.**

I-5 NB & SB MP 306.50 to MP 307.50 (Victory Blvd/Hwy 091 Portland)

Effective August 3, 2018, the I-5 northbound and southbound on/off ramps to/from Victory Blvd/Hwy 091 will be intermittently closed **Sunday through Saturday nights between the hours of 9 PM & 5 AM.**

I-5 NB & SB Exit 307 (Marine Dr/OR99E - Portland)

Effective September 12, 2018, the I-5 northbound and southbound on/off ramps to/from Marine Dr/OR99E will be intermittently closed **Sunday through Saturday nights between the hours of 9 PM & 5 AM.**

I-82 MP 0.00 NB & SB (Columbia River Bridge - Umatilla)

Effective **August 7, 2017**, this section of I-82 will be restricted to **14 feet 00 in. in width**. Load wider than 14 feet 00 in. in width may be accommodated on a case-by-case basis. Contact Washington DOT at 360-704-6340 for additional information.

I-84 WB to I-5 SB (Portland)

Effective November 26, 2018, the I-84 westbound ramp to I-5 southbound will be closed Monday through Thursday nights between 10 PM & 5 AM. Starting Friday night at 10 PM, this ramp will be closed at all hours until Monday morning at 5 AM.

I-84 WB to I-5 NB Ramp Closures (Portland)

Effective October 16, 2018, the I-84 westbound ramp to I-5 northbound will be closed Monday through Thursday nights between the hours of 10 PM & 5 AM. Starting Friday night at 10 PM this ramp will be closed at all hours until Monday morning at 5 AM. In addition, the following on-ramps will be closed during the weekend closures only: **NE 33rd Ave; and NE Sandy Blvd.**

I-84 EB & WB MP 17.12 to MP 17.60 (Troutdale) -- NEW --

Effective January 28, 2019, this section of I-84 eastbound and westbound will be restricted to 14 feet 00 inches in width Sunday through Thursday nights between the hours of 10 PM and 5:30 AM and Friday and Saturday nights between the hours of 10 PM and 1/2 hour before sunrise. Loads wider than 14 feet 00 inches in width may be accommodated on a case by case basis. Contact the Over-Dimension Permit Unit for information.

I-84 EB & WB MP 17.12 to MP 17.60 (Troutdale) -- NEW --

Effective January 28, 2019, this section of I-84 eastbound will be restricted to 18 feet 03 inches in height and 18 feet 02 inches in height westbound Sunday through Thursday nights between the hours of 10 PM and 5:30 AM and Friday and Saturday nights between the hours of 10 PM and 1/2 hour before sunrise.

I-84 EB & WB MP 64.00 to MP 100.00

Effective January 16, 2019 this section of I-84 eastbound and westbound will be restricted to 16 feet 00 inches in width between the hours of 7 PM & 10 AM. Loads wider than 16 feet 00 inches in width may be accommodated on a case-by-case basis. Contact the Over-Dimension Permit Unit for information.

I-84 WB Exit 104 off-ramp to US97 (Biggs)

Effective January 16, 2019, the westbound I-84 off-ramp to US97 (Exit 104) will be restricted to 16 feet 00 inches in width at all hours.

I-84 EB & WB MP 104.20 to MP 105.30 (Biggs)

Effective January 16, 2019, this section of I-84 eastbound and westbound will be restricted to 16 feet 00 inches in width at all hours.

I-84 WB Exit 109 on-ramp from John Day Dam (Rufus)

Effective January 16, 2019, the I-84 westbound on-ramp from John Day Dam (Exit 109) will be restricted to 16 feet 00 inches in width at all hours.

I-84 EB Exit 109 off-ramp to John Day Dam (Rufus)

Effective January 16, 2019, the I-84 eastbound off-ramp to John Day Dam (Exit 109) will be restricted to 16 feet 00 inches in width at all hours.

I-84 EB & WB MP 109.25 to MP 110.50 (Rufus)

Effective January 16, 2019, this section of I-84 eastbound and westbound will be restricted to 16 feet 00 inches in width at all hours.

I-84 EB & WB MP 100.00 to MP 152.00

I-205 NB & SB MP 15.97 to MP 25.70 (Portland)

Effective April 15, 2018, this section of I-205 northbound and southbound will be restricted to 19 feet 00 inches in width from 1/2 hour before sunrise to 1/2 hour after sunset. Loads wider than 19 feet 00 inches in width may be accommodated on a case by case basis. Contact the Over-Dimension Permit Unit for information.

I-205 NB & SB MP 15.97 to MP 25.70 (Portland)

Effective April 15, 2018, this section of I-205 southbound will be restricted to 16 feet 5 inches in height and 16 feet 7 inches in height northbound. Loads higher may be accommodated on a case by case basis. Contact the Over-Dimension Permit Unit for information.

I-205 SB Exit 19 (US26/Division St/Powell Blvd - Portland)

Effective May 28, 2018, the I-205 southbound ramp (Exit 19) to US26/Division St/Powell Blvd will be intermittently closed Sunday through Thursday nights between the hours of 9 PM & 5 AM.

I-205 NB on-ramp from I-84 EB (Portland)

Effective June 18, 2018, the I-205 northbound on-ramp from I-84 eastbound will be intermittently closed Sunday through Thursday nights between the hours of 9 PM & 5 AM.

I-205 NB on-ramp from I-84 WB (Portland)

Effective June 19, 2018, the I-205 northbound on-ramp from I-84 westbound will be intermittently closed Sunday through Thursday nights between the hours of 9 PM & 5 AM.

I-205 NB Exit 23A to US30 Bypass EB (Portland)

Effective June 19, 2018, I-205 northbound Exit 23A ramp to US30 Bypass eastbound will be intermittently closed Sunday through Thursday nights between the hours of 9 PM & 5 AM.

I-205 NB Exit 23B to US30 Bypass WB (Portland)

Effective June 20, 2018, the I-205 northbound Exit 23B ramp to US30 Bypass westbound will be intermittently closed Sunday through Thursday nights between the hours of 9 PM & 5 AM.

I-405 NB Exit 1D to US26/SW 12th Ave (Portland) -- NEW --

US20 MP 99.94 EB & WB (Sisters)

Effective November 28, 2017, this section of US20 is restricted to 14 feet 00 inches in width and/or 154 feet overall length. Mobile homes with eaves are allowed provided the base width does not exceed 14 feet 00 inches in width. Loads wider than 14 feet and/or 154 feet overall length may be accommodated on a case-by-case basis. Contact the Over-Dimension Permit Unit for information.

US97 NB & SB MP 0.28 to MP 0.52 (Biggs Junction)

Effective January 1, 2019, this section of US97 northbound and southbound will be restricted to **18 feet 00 inches** in width.

US97 NB & SB MP 74.09 to MP 75.18 (Madras)

Effective October 22, 2018, this section of US97 northbound and southbound will be restricted to 17 feet 00 inches in width.

US101 MP 347.78 NB & SB (north of Brookings)

Effective July 31, 2017, this section of US101 will be restricted to 16 feet 00 in. in width.

OR47 MP 88.05 NB & SB (Forest Grove)

Effective September 27, 2016, this section of OR47 is restricted to 14 feet 00 inches in width and 135 feet overall length. Mobile homes with eaves are allowed provided the base width does not exceed 14 feet 00 in. in width. Loads wider than 14 feet or 135 feet overall length may be accommodated on a case-by-case basis. OR99W NB & SB MP 62.03 to MP 63.90 (Monmouth)

Effective August 1, 2018, this section of OR99W northbound and southbound will be restricted to 14 feet 00 inches in width Sunday through Thursday nights between the hours of 7 PM & 6 AM. Loads wider than 14 feet 00 inches in width may be accommodated on a case by case basis. Contact the OD Permit Unit for information.

OR126 EB & WB MP 15.84 (Prineville)

Effective June 21, 2018, this section of OR126 eastbound and westbound will be restricted to 14 feet 00 inches in width and 135 feet 00 inches in overall length. Mobile homes with eaves are allowed provided the base width does not exceed 14 feet 00 inches in width. OR130 EB & WB MP 4.15 to MP 8 (Hebo) -- NEW --

Effective February 26, 2019, this section of OR130 eastbound and westbound will be closed between the hours of 8 AM & 4 PM.

OR351 NB & SB MP 0.00 to MP 0.21 (Main St - Joseph)

Effective January 23, 2019, this section of OR351 northbound and southbound will be closed between the hours of 7 AM to 12 PM (noon) for one day only.

OR569 EB Exit to Delta Hwy SB (Eugene) -- NEW --
